VOTER REGISTRATION

Online registration deadline is March 18th, 2020!

If you are not currently registered to vote and would like to vote in this election, you may do so online by March 18th, 2020. Thereafter, you may register in person either on Election Day or by appointment with the Clerk through April 3rd, 2020. Please note, proof of residence is required to register to vote. <u>Click here</u> for a list of acceptable documents.

ABSENTEE VOTING - BY MAIL

An elector must be registered to vote before applying for an Absentee Ballot. If you are unsure of your voter status, click on the link noted in the Voter Registration article above.

Absentee ballots for this election will be mailed out starting Wednesday, March 18th, 2020 to electors on the indefinitely confined ballot list and other electors who had requests on file as of Sunday, March 15th, 2020. Thereafter, ballots will be mailed as soon as possible.

Electors who wish to receive an absentee ballot by mail are encouraged to do so online at MyVoteWisconsin. After submitting your online Absentee Ballot application, please email acceptable Photo ID to the Village Clerk. The URL for acceptable Photo ID is: (https://vnbwi.files.wordpress.com/2020/02/acceptable-photo-id.elections-2020.pdf).

The final day to request an absentee ballot by mail for the April Spring Election is April 3rd, 2020. Absentee ballots must be received by 8:00 PM on election day in order to be counted for this election.

ABSENTEE VOTING - IN PERSON

In-person Absentee Voting is available by appointment starting March 23rd through 5 PM Friday, April 3rd, 2020. **However, the Wisconsin Election Commission is strongly discouraging In Person Absentee Voting and rather is encouraging Absentee Voting by Mail Ballot**. A valid photo ID is required to obtain a ballot. There is no in-person absentee voting on the Monday before the election.
