LAWN CLIPPINGS, YARD WASTE & STORM DRAINAGE | Below are a few reminders to help limit frequency and expenses related to debris removal from the ravine and professional cleaning expenses to unclog storm drains

- Please do not discard lawn clippings or yard waste into the ravine.
- For drains to function at peak capacity, please do not blow grass clippings, leaves or other yard waste into the gutter because debris clogs the drains.
- Please dispose of yard waste as outlined on the <u>Public Works page</u> of the Village North Bay website. The URL is: https://northbay-wi.us/publicworks/

GUTTER & CURBSIDE MAINTENANCE | Roads begin to crack with age and plant growth emerges which reduces the lifespan of pavement. Plant growth causes cracks to deepen and results in premature crumbling of pavement. To help extend the life of our roads and defer repaving and/or repair expenses please remove plant growth from cracks in the curb in front of your home and from the seams that join the road to your driveway and trim grass at your curb after mowing to prevent grass growth in the seams.

ASH BORER | It's time for residents who are on the same bi-annual ash tree schedule to sign up for the 2020 fall treatment. A Google Form will be emailed to property owners with trees that have been part of the coordinated treatment schedule. If a tree has been removed from your property, please complete the form so we can update our database. TREASURER'S NOTES...

DOG LICENSING | *T*o avoid a potential citation from the Wind Point Police Department, please submit your pet's dog license application as soon as possible. If you misplaced the application that accompanied your tax bill, you may download the form from the <u>Village website</u>. State law requires dogs 5 months of age or older to be licensed each year.

WATER & WASTEWATER...

FIRE HYDRANT FLUSHING | The Racine Water Department plans to perform flushing of the water lines throughout the city, including North Bay. Two days prior to the procedure, the city will notify residents by posting temporary signs in the streets. When this procedure occurs, sediment in the lines could cause discoloration to the water. Use caution when running laundry during this time.

RAVINE WATERFLOW | Blockage of or changes to waterflow in the ravine results in erosion issues and/or stagnant water. Please do not dump lawn clippings or yard waste into the ravine to help maintain the natural waterflow and ecosystem.


