2020 TAX BILL | Annual property tax bills are anticipated to be mailed to North Bay property owners during the first week of December. Information on how to pay the tax bill can be found on the tax bill insert and the Village website. Payments are processed by Johnson Bank, 4001 North Main Street, through the drive-up lanes or by mail. Copies of tax bills can be obtained online using Racine County's MyTaxBill web app. Introduced in 2018, tax payments will show up in the Racine County system as soon as they are receipted (note there will be a 2-3 day delay for payments made at Johnson Bank).
