PERMITS | BUILDING, PLUMBING, ELECTRICAL & FENCE

Are you planning renovations, improvements, upgrading or replacing your roof/furnace/air conditioner, all fence installations (new &/or replacement), or any other home project? Permits help protect homeowners by ensuring projects meet current code.

Please notify your Contractor to visit the village website for Building & Zoning information located in the <u>Village Ordinances</u> and the <u>Building & Property</u> page for, permit information and downloadable forms that include VNB Inspector contact information. Permit placards are to be posted and visible on the front of the building prior to the start of your project. Please note, projects may require multiple permits.

Please note, Homeowners who are doing their own work or are acting as their own general contractor are not exempt from obtaining the required permits. 101.65(1r) of the Wisconsin Statutes requires municipalities that enforce the Uniform Dwelling Code to provide an owner who applies for a building permit with a <u>Cautionary Statement</u>.
