ORDINANCE NO. **2021-2**

**AN ORDINANCE TO AMEND SECTION 2.02, CONCERNING APPOINTED
OFFICIALS, OF CHAPTER 2 OF THE VILLAGE CODE RELATING TO
VILLAGE OFFICIALS**

WHEREAS, the Village of North Bay provides for the appointment of various Village Officials by the Village President, subject to confirmation by a majority vote of the Village Board; and

WHEREAS, the Section 2.02 indicates the term of office for the Appointed Officials shall be for a period of two years and the incumbent Official shall continue in until successors are appointed; and

WHEREAS, the Village Board finds that it is in the best interest of the Village to amend Section 2.02 of the Municipal Code to permit the Village Board to appoint Village Officials pursuant to terms as are acceptable to the Village Board.

NOW, THEREFORE, the Village Board of the Village of North Bay, Racine County, Wisconsin DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Chapter 2 of the Village of North Bay Municipal Code entitled, "Officials," Section 2.02 entitled, "Appointed Officials" is hereby repealed and re-created as follows:

2.02 APPOINTED OFFICIALS Attorney, Building Inspector, Electrical Inspector, Plumbing Inspector, Emergency Government Coordinator, Assessor. The Village officials hereinafter set forth shall be appointed by the Village President, subject to confirmation by a majority vote of the members of the Board: Attorney, Building Inspector, Electrical Inspector, Plumbing Inspector, Emergency Government Coordinator, Assessor. Such positions will be filled by agreement with such service providers, on such terms as are acceptable to the Village Board.

SECTION 2: SEVERABILITY

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE

This ordinance shall take effect on December 13th, 2021 after passage and posting and/or publication as provided by law.
