Trustee's Report (2) - Rick Cermak |

- One of two Village Hall lift station pumps was taken offline due to a faulty valve. Repairs will be completed upon receipt of backordered parts. Should conditions require additional capacity, the offline pump can be put back into service.
- Racine Water Utility Water Main Emergency | On Friday, January 6th, 2023, a water main broke in the rear of 3621 North Bay Drive (Pepich/Englander). The Racine Water Utility requested to meet with President Schall and Water & Wastewater Trustee Cermak.

Constable's Report - Kristin Wright | November & December reports issued.

- Wind Point Police Department (WPPD)
 - WPPD Chief Von Drasek, Wind Point received a \$23,000 donation from Fisk Johnson,
 CEO of SC Johnson directed to WPPD. Funds will be used for a second squad, evidence kits, etc.
 - o October 2022: 80 Citations' 79 Police Activity/incidents
 - November 2022: 78 Citations; 83 Police Activity/incidents
- Caledonia Fire & EMS | Per Chief Henningfield, calls increased 244%
 - Village Hall passed the fire inspection on 12/9/2022
 - November 2022 No calls
 - October 2022 Calls: 3 rescue runs (1 not considered emergency; appointment). Average response time 9:51
- Animal Welfare No report at this time.

Treasurer's Report – Bob O'Brien | Presented by Clerk Panthofer. Treasurer O'Brien emailed the November 2022 financial reports to the Board on January 9th, 2023 and noted that December

2022 reports will not be available until late February or March.

- Deputy Clerk Elections | Susan Hamilton accepted the offer to become the limited scope Deputy Clerk for Elections and agreed to the Village's quarterly payroll schedule.

The Board agreed to propose the modification. Action is pending the receipt of a revised MOU which includes the proposed modification.
