Call the 2023 Board of Review (BOR) to order | President Schall called the 2023 BOR to order at 7:00PM.

Confirmation of appropriate BOR and Open Meeting notices | Clerk Panthofer confirmed required legal notices were posted in the following locations: Racine Journal Times, Village of North Bay website and on the Village Hall bulletin board. A notice of date change is also scheduled to run in the Racine Journal Times on May 12th and June 9th and has already been posted on the Village website and on the Village Hall bulletin board.

Select a Chairperson for the BOR | Robert O'Brien nominated Mark Schall to serve as Chairperson of the 2023 BOR and Rich Schmitt seconded the nomination. No other nominations were put forth. Roll call vote: Rick Cermak AYE; Rich Schmitt AYE; Robert O'Brien AYE; Mark Schall AYE; Dori Panthofer AYE. Motion carried at 7:05PM.

Select a BOR Vice-Chair | Mark Schall nominated Robert O'Brien to serve as the Vice-Chair. Dori Panthofer nominated Kristin Wright to serve as the Vice-Chair. No other nominations were put forth. Following a brief discussion, Rich Schmitt seconded the nomination of Robert O'Brien to serve as Vice-Chair. Roll call vote: Rick Cermak AYE; Rich Schmitt AYE; Robert O'Brien AYE; Mark Schall AYE; Dori Panthofer AYE. Motion carried at 7:08PM.

Verify that at least one BOR member has met the annual mandatory training requirements | Clerk Panthofer verified that both she and Robert O'Brien fulfilled the annual training requirements. Clerk Panthofer digitally filed the training affidavits on the Wisconsin Department of Revenue website.

Assessor Jim Henke | The state of Wisconsin has a two number system; local assessments and equalized value. The state sets equalized value. Equalized value is a means to split the various levies by Racine County (Racine Unified, Gateway, etc.). Based on recent North Bay sales, the WI DOR recalculated North Bay's equalized value for 2023.

According to the Wisconsin Department of Revenue (DOR), the Village of North Bay's local assessed value was at 82% of the equalized value. To comply with the state, Village assessed value must be at 100% of equalized value. Land value hasn't changed in years and land is not valued on a linear scale.

The average adjustment will increase approximately 30%. The mill rate will be adjusted down. Some properties will receive larger increases based upon activity that increases value. Assessed value of land will be updated. Assessed value of improvements will be updated.
