3. President Schall introduced both Patrice Brunette & Scott Legue from the Racine County Public Works. Racine County will dispatch crews to complete tree removal and chipping.

North Bay is also coordinating clean up efforts with the Village of Wind Point Public Works Supervisor Scott Rewolinksi.

Today, May 21st, 2025, the Village learned that several municipalities have surplus equipment and staff who have offered to assist with clean up in the Wind Point and North Bay.

Public Comment

Attendees discussed storm cleanup efforts and emergency communication following a recent storm. President Schall explained that cleanup with Wind Point is an emergency and volunteer effort, not incurring costs for the village. Residents expressed concern about the lack of communication, prompting discussions about developing an emergency plan for future events like tornados or snowstorms, etc. The Constable's role in public safety communication was also guestioned.

The village is working to reevaluate and improve communication protocols. Cleanup efforts, including the collection of branches and firewood logs, are scheduled to begin on May 22nd, 2025, with an email announcement to residents. The topic will be removed from the May 23rd, 2025 agenda.
