ABBREVIATED REGULATIONS | Please refer to Chapter 8, Section 8:14 (Ordinance 2013-4) - Fences of the North Bay Code of Ordinances for specific definitions, regulations restrictions and allowances.

- Planning Commission approval is required prior to installation.
- No person shall construct or cause to be constructed, in whole or in part, a fence with barbed wire, razor wire, electrified wire, or any wire fabric within the Village.
- The good side of the fence shall face toward the adjoining property and toward the public right-of-way... The Public Works Trustee shall determine the "good" side.
- Any fence located in an easement area that must be removed so as to facilitate utility access or repair shall be removed at the fence owner's expense, without recourse to the Village or utility.
- No fence may be located within the front of the yard.

APPLICANT AGREEMENT | The undersigned Applicant, as Owner or Agent of the Owner:

1. Is responsible for the fence being located on the intended property and CERTIFIES that the fence does not encroach into any utility easement, public right-of-way, vision clearance area, or neighboring properties. The APPLICANT further AGREES that if the fence is built in or across any of the areas, the APPLICANT will be RESPONSIBLE for REMOVING and REPLACING the fence.
2. Agrees to: Comply with the Village of North Bay Ordinances, state statutes, federal regulations, and with the conditions of this permit as described above; The Owner or Agent of the Owner will obey any and all lawful orders of the Building Inspector of the Village of North Bay; That the issuance of this permit creates no legal liability, express or implied, of the Village or Inspector, and certifies that all the above information is accurate.
3. Understands that by issuing a Fence Permit, the VILLAGE IS NOT CERTIFYING that the intended location of the fence is not within an easement or right-of-way or on the identified parcel. A full title search would be needed by the OWNER to verify the presence of all easements and rights-of-way and a certified survey would be required by the owner to identify the precise boundaries of the property. **NOTE: Permits are valid 2 years from date of issue.**
